The following rules and regulations apply to the use of The Anchor, an Avon Lake Recreation Facility Sponsored by PolyOne PolyOne (the "Facility"):

1. Renter shall comply and cause all participants to comply with all applicable City, state and federal statutes, laws, ordinances, rules and regulations, including but not limited to those pertaining to occupancy, fire and safety.
2. Renter shall be responsible for the conduct of all Guests.
3. Renter shall be present at all times that any Guest is using the Facility.
4. Renter shall upon demand reimburse the City for any damage to the Facility or equipment of the Facility caused by or attributable to the use of the Facility by Renter or Renter's Guests.
5. Use of the Facility for less than the scheduled time shall not entitle Renter to a refund of any portion of the Rental Fee.
6. Smoking is not permitted in the Facility.
7. The sale or consumption of alcoholic beverages is not permitted in or at the Facility.
8. Renter is responsible for clean-up of the Facility. Equipment must be returned to their original locations, and the entire Facility must be returned to its original condition. Clean-up includes placing all trash in or near trash receptacles.
9. All personal items and equipment brought to the Facility by Renter or Guests must be removed following the rental. Locks must be removed from the lockers. The City is not responsible for lost, stolen, misplaced and/or broken personal items or equipment.
10. Renter must be at least twenty one (21) years of age.
11. Gambling and games of chance are prohibited.

**Cancellation Policy:** The renter may cancel the rental up to seventy two (72) hours prior to event. A full refund of the rental fee will be issued. If the renter cancels after the 72 hour grace period, the renter will forfeit their rental fee unless they reschedule within thirty (30) days of the signed rental date.
